THE CENTER, A FULL-SERVICE COMMUNITY CENTER, INCLUDES A LARGE MULTI-PURPOSE ROOM, GALLERY SPACE, CONFERENCE ROOMS, A LIBRARY/READING ROOM, AND THE CAMP REHOBOTH COURTYARD. CR'S CAMPSAFE AND HIV/AIDS SCREENING AND EDUCATION PROGRAMS, CONSIDERED AN ESSENTIAL HEALTH SERVICE, CONTINUED DESPITE THE COVID PANDEMIC. IN 2020 CR HAD 6 TESTING LOCATIONS IN SUSSEX COUNTY, REACHING NEW
