An Entertainment Stage will be positioned in front of CAMP Rehoboth, with a variety of entertainers alternating 15-20 minute performances every 45 minutes, starting at the Event Kickoff at noon. Additional acts will perform at 12:45, 1:30, 2:15, 3, 3:45 pm.

All vendors must agree to adhere at all times to all rules, regulations and policies of CAMP Rehoboth, Inc. and to follow all directions and instruction of its officials and personnel. All vendors must agree to release, relieve, discharge, indemnify, defend and hold harmless, CAMP Rehoboth, Inc., its officers and agents, the City of Rehoboth Beach and festival participants from all claims, losses, suits, damages, judgments, expenses, costs and charges of every kind, including without limitation, court costs, and attorney's fees, resulting from its occupancy of the space herein under this contract by reason of personal injuries, loss of life or property damages. And to release the above organizers from any loss, theft, vandalism and/or fire during this event on October 15, 2017.

1. Set up will begin on October 15, 2017 at 9am and must be completed by 11:30 am. The Block Party begins promptly at 12 noon. Specific set up times and location of your booth will be sent to you in advance. If you do not comply with your set-up time, you will not be allowed admission for set-up.
2. Vendor Booth hours of operation will be from noon to 4 pm. Organizers will allocate space unless prior arrangements have been made. Participating vendors will be assigned a designated space on Baltimore Avenue and will be able to rent 10'x10' tent space(s), or provide their own. Any special vendor needs will be addressed on a case by case basis.
3. Vendors may furnish their own tents, tables, chairs, and equipment. If electricity is necessary, vendors must provide their own silent generators and have a fire extinguisher.
4. We will provide a 10 x10 tent if ordered by October 1.
5. Spaces must be kept neat and clean.
6. Vendors must remain open until 4pm closing time. No exceptions.
7. All food vendors must hold and display current food preparation and sales license and must meet all health and safety regulations required by the State of Delaware for storage and preparation of food items.
8. NO sale of alcoholic beverage will be allowed by any vendor. Alcoholic beverages sold by the restaurants on the block or purchased at CAMP Rehoboth may not be taken off premises.
9. All vendors MUST be packed and vacated from Baltimore Avenue by 5 pm unless prior approval has been given by the organizers or the City of Rehoboth Beach. Volunteers will be on-hand to assist with general break-down but vendors are asked to leave their space clean and free of debris.
